Becoming an ever more sustainable, positive impact business is an important part of Informa's business strategy, and over the last decade, we have been progressively building capability and expertise around ESG and sustainability.

In 2020, we launched <u>FasterForward</u>, a structured programme to accelerate the pace and scope of our activities over a five year period, including a series of commitments and targets. Under this programme, we are reporting our activity and sharing information under the Global Reporting Initiative (GRI), to better assist investors and other stakeholders understand our work and performance.
